I. Conference Overview

The PACIFIC RIM CONFERENCE OF CERAMIC SOCIETIES (PACRIM) is a biennial conference held through collaboration amongst the ceramic societies in the Pacific Rim region, i.e., the Chinese Ceramic Society, the American Ceramic Society, the Ceramic Society of Japan, the Korean Ceramic Society, and the Australian Ceramic Society, with the objectives to promote the development and exchange of ideas on advanced ceramic materials, technologies, and applications. Since the 1st event held in the United States in 1993, the PACRIM conference has been well-received by scholars, scientists, and engineers around the world. Therefore, the PACRIM conference has become a world well-known prominent forum for discussion and exchange on advanced ceramic materials, technologies, and the up-to-date engineering applications. The 15th event of PACRIM15 to be held in Shenzhen will be the second time, 16 years after the event for the first time held in Shanghai in 2007, that this international symposium is held in China.

The 13th International Conference on High-Performance Ceramics (CICC-13) is a series of international conferences initiated by the Chinese Ceramic Society. Since the 1st CICC held in 1998, the CICC conference series has evolved into an internationally renowned ceramic event. This year, the two conferences (PACRIM15 & CICC-13) have been integrated with aims to provide an international platform for scholars, scientists, engineers, and entrepreneurs from around the world to exchange and share up-to-date development on current cutting-edge academic researches and technology applications.

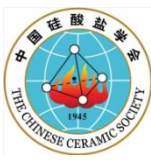

IV. Requirements for Application of Financial Sponsorship and Advertising Space Sponsorship

1. Application Steps

(1) The corporation who is interested in the sponsorship shall fill in the application form after confirming their intention with the organizing committee;

(2) After receiving the sponsorship application form, the organizing committee will send the sponsorship contract to the corporation. After agreeing with the contract, the corporation shall send a scanned copy of the contract with representative signature plus company seal stamped to pacrim15@126.com;

(3) Remit the full amount of financial sponsorship fee to the designated bank account within seven working days after receiving the signed sponsorship contract, and also send a copy of remittance record (a scanned copy or bank transfer record);

(4) After receiving the financial sponsorship fee, the organizing committee will send a copy of official confirmation and receipt via email.

2. Sponsorship Requirements

(1) If the corporation fails to remit the sponsorship fee within seven working days after receiving the financial sponsorship contract, the organizing committee reserves the right to cancel the sponsorship application;

(2) If the corporation transfers the expo space without the approval or displays products and/or materials inconsistent with approved guidelines for exhibition, the organizing committee reserves the right to revoke the exhibitor's qualification and rights, and the full cost for the sponsorship will not be refunded, and the corporation shall bear all of the legal liabilities;

(3) All corporations shall comply with the regulations set by the organizing committee and the conference venue, and cooperate with the local emergency department for guidance and rectification in case of the occurrence of emergency event;



(4) In order to ensure the official image and integrity of the conference, the organizing committee reserve the right to make the final decision and approval on transfer of expo space;

(5) The corporation that gives up the exhibition after paying the sponsorship fee will not receive refund;

(6) Advertising products and promotional materials from corporation shall not infringe the intellectual property and rights of any third-party. In case of infringement disputes, the corporation shall bear all legal liabilities;

(7) If the conference cannot be held as scheduled due to weather, natural disasters, or other irresistible factors or government factors, the organizing committee reserves the right to adjust the time and/or place without assuming any of responsibilities.
